IO of the case Mr. Arvind MR Superintendent.

This complaint has been filed by a public servant Sh. Arvind MR, IO in discharge of his duties. He has moved an application for dispensing with his preliminary examination and for his exemption from personal appearance for future dates on the ground that he remains busy in official duties and it is not possible for him to attend the court on each and every date of hearing and that he be therefore allowed to be represented through the Special PP. In view of the submissions made, the preliminary examination of the complainant is dispensed with and he is exempted from personal appearance during trial

Perused the complaint.

It is the case of the prosecution that on the basis of secret information on 15.02.2024, 50.070kg of pseudoephedrine was recovered from accused Mukesh PU, Mujeepur Rehman and Ashok Kumar while accused Jaffar Sadiq and S. G.

Sathanananthan procured and packed the contra-band while contra-band was booked by accused Mukesh PU in chennai on instruction of accused Jaffar Sadiq and S. G. Sathananatham. CRCL result is positive for pseudoephedrine hydrochloride therefore, on the basis of documents filed alongwith complaint and complaint, undersigned takes cognizance of the offence punishable u/s 9A/25A/29 NDPS Act.

Documents be supplied accused persons within 3 days by the IO after due acknowledgment. Accordingly, the application filed on behalf of accused S. G. Sathananathan u/s 207 CrPC stands disposed off.
