STATE OF DELHI Vs. AJAY alias HANUMAN

Accused Ajay @ Hanuman, Kailash, Anada Ram @ Bano and Vinod Yadav produced from JC.

IO/SI Jaswinder Singh in person.

IO has filed the supplementary charge-sheet qua the FSL result. Same be checked.

As per the charge-sheet, on 31.01.2024, upon secret information accused Ajay @ Hanuman and Kailash were apprehended from near ISBT, Sarai Kale Kha, New Delhi and from the green color *pitthu* bag carried by accused Ajay @ Hanuman, three packets containing 2.994 Kg opium were recovered. From the maroon color *pitthu* bag carried by accused Kailash, 4 packets containing 3.300 Kg opium was recovered.

During the investigation, at the disclosure of accused Ajay @ Hanuman on 02.01.2025, accused Anadara Ram @ Bano's pitthu bag 9 packets containing 8.150 Kg opium was recovered. Thereafter, on 10.01.2025 at the supplementary disclosure of accused Ajay @ Hanuman, from the truck of accused Vinod Yadav 17 packets containing 16.252 Kg opium was recovered, which was kept in the wooden box just below the driver and conductor seat. There is total recovery of 30.726 Kg of opium in the present case. During the investigation, it was found that the truck of accused Vinod Yadav was carrying a fake number plate of "UP53ET9130", wherein the actual number of the truck was "UP53ET9967" and the said truck was registered in the name of one Manoj, who is stated to be the brother of accused Vinod Yadav.

As per the FSL result, the samples recovered from the possession of the accused persons were found positive for opium, wherein the percentage of morphine was found more than 0.2% of morphine.

Prima facie commission of the offences punishable U/s 18(b) r/w Section 29 NDPS Act is made out. Furthermore, commission of offence punishable U/s 336 (3)/340(2) BNS, 2023 is also made out. Since, the truck belonging to Manoj was used in transporting/trafficking of the contraband, prima facie

commission of offence punishable U/s 25 of NDPS Act, 1985 is also made out against Manoj, S/o Sh. Ram Naresh Yadav.

Copy of the charge-sheet and supplementary charge-sheet is supplied to the accused persons Ajay @ Hanuman, Kailash, Anada Ram @ Bano and Vinod Yadav against due acknowledgment.

Let fresh summons be issued to accused Manoj Yadav S/o Sh. Ram Naresh Yadav through IO/SHO concerned for the NDOH.

Re-list for appearance of accused Manoj Yadav and for scrutiny of documents and addressing arguments on the point of charge on **31.01.2026**.
