This is a transfer application for seeking allocation of all the nine complaint cases U/s.138 of Negotiable Instruments Act, 1881 bearing Nos. 4803/2025, 5943/2025, 8851/2025, 22241/2025, 46808/2025, 29469/2025, 9618/2025, 42342/2025 and 63492/2025 filed by the petitioner against the respondent into one court whereas presently these cases have been assigned to five different courts.

Snehil Sharma, Ld. JMFC (NI Act)-01, PHC, NDD and CC NI Act No.63492/2025 pending in the court of Sh. Siddhant Kumar, Ld. JMFC (NI Act)-05, PHC, NDD are withdrawn from the respective courts and are assigned to the court of Ms. Vanshika Mehta, Ld. JMFC (NI Act)-04, PHC, NDD for **23.03.2026 at 02.00 pm**.

The parties are directed to appear before the court of Ms. Vanshika Mehta, Ld. JMFC (NI Act)-04, PHC, NDD on **23.03.2026 at 02.00 pm**.

Ahlmad concerned is directed to send the file before the transferee court forthwith. Copy of this order be sent to the courts concerned.
