Disposal of Bail Application

1– Present bail application has been moved on behalf of accused Shivani Sharma to release her on bail.

2– Ld. Counsel Ms. Anam Azad for accused has argued that the case of present accused Shivani Sharma is almost on the same footing with that of other co–accused named as Ajmeri Khatoon. Regular bail of co–accused Ajmeri Khatoon has been granted by this Ld. Court vide order dated 30–06–2026. According to FIR co–accused Ajmeri Khatoon is at serial no. 5 while present accused Shivani Sharma is at serial no. 6 and both accused are women. Injuries received by the injured are simple in nature and prayed to allow the bail.

3– Ld. D.G.C.(Crl.) has submitted that during altercation the complainant called the police of 112 number and accused have

beaten the police. As per injury report, injured Mohd. Yunus received following injuries:—

1—COP RIGHT HAND THUMB AND INDEX FINGER. REFER TO CDH KUSHINAGAR TO ORTHO SURGEON FOR EXPERT OPINION AND FURTHER MANAGEENT.

2— COP NECK REFER TO CDH KUSHINAGAR TO ORTHO SURGEON FOR EXPERT OPINON AND FURTHER MANAGEMENT.

3— ABRASION 1 CM X 0.3 CM ON PROXIMAL PHALANGES MIDDLE FINGER OF RIGHT HAND 6.5 CM ABOVE TIP OF FINGER.

4— ABRASION 1 CM X 0.2 CM ON PROXIMAL PHALANGES OF RING FINGER OF RIGHT HAND 6 CM ABOVE TOP OF RING FINGER.

and has prayed to reject the bail.

4— According to FIR “Myself HCP Juber Ahmad S/O Ikramuddin R/O Village Digghi, P.S. Kolwali Chandauli, District—Chandauli is domicile of this place. Today on 17-06-2026 my duty was at UP112 project PRV vehicle 2514 at P.S. Kolwali Padrauna. Today morning at 10.35 event no. 09638 caller Jamshed Akhtar (Gram Pradhan) gave information that altercation between two parties. On receiving this information, myself HCP alongwith other associates and driver Mohd. Yunus and ladies Constable Arju Prasad reached at the place of occurrence then some people came with Kaif Raza and restricted them in making video and villegers Harun Shah, Niyaz, Juef Razam, Ajameri Khatoon, Shivani Sharma and Ranjana snatched his mobile and with intention to kill them, pressed their neck and beaten on their hands. Pradhan of the village and some other people intervened but they brought Sharp Tangi and attacked on Mohd. Yonus with intention to murder him but somehow he saved his life. The people who undersoot the law inside the village, the women and children remain inside the burn out. They went inside the mosque and hid. When additional force came from police station, then our lives saved. Accused persons fledaway threatening them. They also said that they are local people and we have lot of reach. You people will see. The above mentioned accused deliberately obstructed the public servant in their duties. It is therefore prayed that urgent information is being given and further legal action be taken.

5– I have heard the Ld. Counsel for both the parties and perused the case diary.

6– From the perusal of case diary, it transpires that present accused is woman and co–accused Ajmeri Khatoon has already been granted bail by this Ld. Court vide order dated 30–06–2026 and the role of the present accused is on the same footing with that of co–accused Ajmeri Khatoon. According to FIR co–accused Ajmeri Khatoon is at serial no. 5 while present accused Shivani Sharma is at serial no. 6. Accused is languishing in jail since 18–06–2026. Present accused is a woman, therefore, she is given the benefit of Proviso of Section 480(1) of BNSS. Due to the above mentioned reasons, this Ld. Court finds it to be a fit case for bail and therefore, bail application deserves to be allowed.

Order

Bail Application of accused Shivani Sharma is hereby allowed. Let accused be released on bail on furnishing his personal bond of Rs. 1,00,000/– and two sureties in the like amount to the satisfaction of the Magistrate concerned with the conditions that:–

1– Accused will present in person before the Trial Court at the time of Charge and statement U/S 351 BNSS.

2– Accused will not intimidate or harass the informant or any of the witnesses and shall co–operate with the trial.

3– Accused will not leave India without prior permission of the Trial Court.
