ORDER

Police identified the accused. Accused and defacto complainant/V. Sridhar are present and in view of National Lok Adalat, they filed Petition submitting that, they intends to compromise the case.Heard. Perused the record. In view of compromise by both the parties, the case is placed before Lok adalath.The alleged offences against the Accused is under section 379, 411 of IPC. The offence is under sec.379 of IPC which are compoundable in nature. Hence, the matter is referred to Lok Adalat Bench for recording compromise.Accused and defacto complainant/ V. Sridhar are present. Heard both sides. Perused the record. At the intervention of the Lok Adalat Members, the matter is settled amicably and the alleged offence against the Accused is under Sec.379, 411 of IPC which is compoundable offence. Hence, the matter is compromised. Compromise recorded. Accused is acquitted under Sec.320(8) of Cr.P.C. Bail bonds of the Accused if any shall stand canceled. The unmarked case property i.e. 1. Gold chain-1 wg. about 9.10 grams, 2. Gold Bracelet wg. about 16.60 grams, total W/Rs. 1,20,000/- and one Appi auto bearing No.TS 04 UC 1637 which was already returned to its owner towards interim custody vide Crl.M.P. No.322 and 323/2022, dt.14.307.2022 and 01.08.2022 is made absolute.
