There are various grounds numerated in the plaint which are repeated herein for the sake of brevity. However at present there is an elected body and someone has to do the work for defendant no.1 Association. Only because the present petition is filed, I am not inclined to grant injunction against defendant no.1 thereby restraining them from performing any vital function. Whether elections are illegal or not is to be decided in due course.

In the circumstances, u/O 39 rule 1 and 2 CPC is hereby dismissed.

In the circumstances, defendant is directed to file WS within 30 days with advance copy to the plaintiff within same duration. Within 30 days from the date of receipt of WS, rejoinder to be filed by plaintiff, if any.

Both the parties are directed to file original documents on record, if not already filed within two months. Both the parties to appear along with their affidavit of admission/denial on the next date of hearing.
