

ORDER BELOW EXH.1

1] Perused application and say. Heard Advocate for applicant and APP for the State.

2] This is first bail application filed under section 439 of Cr.P.C. by applicant in respect of his arrest in C.R. no. 336/18 registered at Khadki Police Station for the offence punishable under section 354D,506 of the Indian Penal Code and under section 11,12 of the Protection of Children from Sexual Offences Act, 2012. It is alleged that father of victim lodged report stating that on 04.10.2018 at 8.30 p.m. there was rush of people in front of his house, victim i.e. his daughter was in frightened condition and told that applicant followed her and stopped her vehicle, made obscene gestures towards her, used filthy language and threatened to throw acid on her face, he thereby outraged her modesty.

3] According to applicant he is falsely implicated in this matter. There is previous enmity. Applicant is 22 years old and residing at Khadki, Pune. He has no criminal antecedents. He is ready to abide the conditions. Hence, he prayed to release him on bail.

4] APP objected this application on the ground that investigation is in progress. Applicant will pressurize victim and witnesses. There is possibility of tampering prosecution evidence. So, she prayed to reject the application.

5] Allegations against the applicant are serious. Applicant is interrogated. Considering allegations and nature of offence investigation is practically over. Personal custody of applicant is not required. Applicant is resident of Khadki, Pune. Applicant is 22 years

old and has no criminal antecedents. No purpose would serve by keeping the applicant behind bar for unknown period. Due to all above reasons application deserves to be allowed with following order -

ORDER

- 1] The application is allowed.
- 2] The applicant Akshay Anil Daware be released on executing P.R. bond of Rs.25,000/- with one or two solvent sureties in the like amount.
- 3] The applicant shall not tamper the prosecution witnesses in any manner.
- 4] The applicant shall attend Khadki Police Station on every Monday between 11.00 a.m. to 2.00 p.m. till the charge-sheet is filed.
- 5] The applicant shall not meet the victim and threat and pressurize the victim and shall not enter into vicinity of residence of victim.
- 6] The applicant shall co-operate investigating machinery as and when required.
- 7] Prior to furnishing surety, the applicant shall submit his address proof, mobile number and inform about the change in address and mobile number.
