

ORDER BELOW EXH.1

1] Perused application and say. Heard Advocate for applicant and APP for the State.

2] This is first bail application filed under section 439 of Cr.P.C. by applicant in respect of his arrest in C.R. No. 426/18 registered at Bhosari Police Station for the offence punishable under section 354-D of the Indian Penal Code. It is alleged that father of victim lodged report stating that prior to two months from 08/11/18 applicant was following victim i.e. his daughter age about 17 years. On 08/11/18, applicant obstructed victim when she was proceeding towards bathroom and told her that he likes her. He thereby outraged her modesty.

3] According to applicant he is falsely implicated in this matter. He is doing business and residence of Bhosari, Pune. He is earning member in his family and has no criminal antecedents. He is ready to abide the conditions. Hence, he prayed to release him on bail.

4] APP and I.O. objected this application on the ground that investigation is in progress. Applicant will pressurize victim and witnesses. There is possibility of tampering prosecution evidence. Applicant is originally resident of Tal-Akkalkot, Dist-Solapur. There is possibility of absconding of applicant. So, they prayed to reject the application.

5] Allegations against the applicant are serious. Considering allegations and nature of offence investigation is practically over. Present custody of applicant is not required. Applicant is earning member of family and has no criminal antecedents. He is temporary

resident of Bhosari Pune. Applicant is interrogated. No purpose would serve by keeping the applicant behind bar for unknown period. Due to all above reasons application deserves to be allowed with following order -

ORDER

- 1] The application is allowed.
- 2] The applicant Rahul Ramanna Barhanpure be released on executing P.R. bond of Rs.30,000/- with one or two solvent sureties in the like amount.
- 3] The applicant shall not tamper the prosecution witnesses in any manner.
- 4] The applicant shall attend Bhosari MIDC Police Station on every Monday between 11.00 a.m. to 2.00 p.m. till the charge-sheet is filed.
- 5] The applicant shall not threat and pressurize the victim.
- 6] The applicant shall not meet victim, shall not harass her and shall not repeat the offence.
- 6] The applicant shall co-operate investigating machinery as and when required.
- 7] Prior to furnishing surety, the applicant shall submit his address proof, mobile number and inform about the change in address and mobile number.
