Firstly, on 01.03.2021 at 2.30 a.m. at Hosabettu Village, Mangaluru Taluk, you accused No.1 committed lurking house trespass by night and entered into the house of CW-1 – Maxim D'Souza by breaking open the front door lock by using a weapon brought by you in order to commit theft and thereby committed an offence punishable U/s 454, 457 of IPC, within my cognizance.
