Accused Mohit Chauhan @ Mangal is without arrest.
Accused Ayush Tomar @ Ashish is without arrest.
Sh. Akash Rajawat, Ld. counsel for accused Mohit and Ayush.

Fresh sessions case is received by assignment. It be checked and registered.

Today, on calling the case, accused Prince has been produced in J/C. Accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish against whom the chargesheet has been filed without arrest, have also appeared.

Ld. Counsel for the accused has filed vakalatnama and two separate applications for grant of bail of the accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish. Copies thereof have been supplied to Ld. Addl.PP for the State.

Ld. counsel for the applicants/ accused has submitted that applicants/ accused Mohit Chauhan @ Mangal is 22 years of age and he is studying in college and pursuing graduation and submitted that accused Ayush Tomar @ Ashish is also 22 years of age and pursuing his graduation and the charge-sheet has been filed against both of them without arresting them and prayed for grant of bail.

Ld. Addl.PP for the State has submitted that since the chargesheet against the accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish has been filed without their arrest, so, he has no objection, if their bail applications are allowed.

Since, in the case in hand, chargesheet against accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish has been filed without arrest, so, Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish are admitted to bail and they are directed to furnish personal bonds in the sum of Rs.10,000/- with one surety in the like amount each.

At this stage, Ld. counsel for the accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish seek time to furnish personal bonds and surety bonds. Same is granted.

Accordingly, matter stands adjourned for furnishing of personal bonds and surety bonds on behalf of accused Mohit Chauhan @ Mangal and Ayush Tomar @ Ashish for **14.10.2023** and for consideration on charge for **17.10.2023**.

IO is called upon for the next date of hearing i.e., 17.10.2023.
