Summons issued to PW2 HC (now ASI) Priyavrat for recording of his further cross-examination has been received back unexecuted with the report of Inspector Satish Kumar of SOS-I/Crime Branch, Prashant Vihar, Sector-14, Rohini, duly forwarded by ACP/SOS-I/Crime Branch, that said PW is on 06 days CL vide DD no. 10 dated 03/12/2019. Being on CL is no ground for non-service of said PW specially when Id. Counsels for A-1 & A-3 have submitted that said PW is deliberately evading appearance before this Court and his evidence is required to be completed first as he was the shadow witness as per the case of prosecution. Hence issue show cause notice to Inspector Satish Kumar of SOS-I, Crime Branch, Prashant Vihar, sector-14, Rohini, as well as to ACP concerned as to why action should not be taken against them for non-compliance of order of this Court and non-service of HC (now

ASI) Priyavrat. Issue fresh summons to PW HC (now ASI) Priyavrat through Special C.P., Crime Branch. A copy of the order be also served upon him for information and compliance and for ensuring the presence of HC (now ASI) Priyavrat on next date of hearing.

PW1 HC (now ASI) Rajbir present for his cross-examination is discharged unexamined for today only at the request of Id. Counsels for A1 & A3 who have stated that this PW was a member of the raiding party and that cross-examination of shadow witness (PW2) is required to be recorded first so that the accused persons may not get prejudiced.

The next date of hearing of 10/12/2019 already given, is recalled as it is unlikely that PW2 HC (now ASI) Priyavrat will be served within such a short span of time.
