The accused-petitioner was arrested with 25 liters of illegal Mahuya liquor which was seized by the police from his possession. Moreover, the accused-petitioner is in judicial custody since 30/09/2022. He is suffering with ailments of eyes for which he has adduced medical certificate issued by Sanjeev Netralay Super Specialty Retina Hospital, Discharge certificate as well as the contentions as made by his advocate that accused is suffering with serious diabetes disorder. Considering the above facts, circumstances, quantity of liquor and custody period of the accused-petitioner, I am inclined to release the accused-petitioner namely Sitaram Keshri on bail on furnishing bail bond of Rs.5,000/- with two sureties of alike nature.
