DECREE

1. that the suit is decreed with costs.
2. that the directing the defendants to pay a sum of Rs.1,53,939/- together with interest at 9% per annum for the principal amount of Rs.82,450/- from the date of filing of the suit till the date of decree and there after interest at the rate of 6% p.a till realization.
3. that the defendants to pay a sum of Rs.7,566/- towards the cost of the suit.
