Both the accused are present on bail with counsel Sh R.K.Gupta.

No Doctor has appeared despite being served to prove aforesaid MLCs. Even MS, GTB Hospital is not present despite being directed to appear personally.

Considering the same, **summons be issued afresh to MS, GTB Hospital to appear in person before the Court on next date of hearing.**

IO ASI Satyapal is present. He has filed an application for adding name of PW Rajesh, one of the victims, in the list of witnesses. It is admitted by the IO that he had not recorded statement of witness Rajesh, although, he also stated that he had recorded his statement in the hospital, but same was misplaced. It appears to be the utter negligence on the part of the IO for not filing a proper chargesheet, as he has failed to place on record the statement of one of injured Rajesh and he has also not mentioned his name in the list of witnesses. It appears that even superior Police officers have not acted diligently as the chargesheet has not been properly verified and ratified by Senior officials/officers of Police Department and also Prosecution Branch.

Let copy of this order be sent to DCP, East, Addl. Commissioner of Police (Eastern Range), Commissioner of Police, as well as to Chief Prosecutor, East District and Director of Prosecution for taking action against the erring officials/officers and compliance report be sent to this Court by next date of hearing.

Ld. Counsel for accused persons submits that he has no objection if name of Rajesh, one of the injured/victim is added in the list of witnesses.

Considering the same, **application for adding name of injured Rajesh in the list of witnesses stands allowed. Consequently, name of injured Rajesh is added in the list of witnesses. He be summoned for the next date of hearing.**
