ORDER BELOW EXH.01

(Passed on 22.12.2022)

1] This is an application under Section 2 of the Bombay Regulation Act, 1827, for grant of heir-ship certificate in the name of the applicants.

2] It is the contention of the applicants that, their father deceased Purushottam Dungaji Moyal is died 30.08.2002. The applicants further contended that, their mother Rukhmini Purushottam Moyal is also died on 04.12.2021. The father and Mother of deceased Purushottam Dungaji Moyal are also died long ago. Therefore, the applicants contended that they are the only legal heirs of the deceased Purushottam Dungaji Moyal and prayed to issue heirship certificate in their name.

3] It appears from the record that, the applicant no. 1 and 2 are daughters of deceased Purushottam Dungaji Moyal. The wife of deceased Purushottam Dungaji Moyal and mother of the applicants is also died. Therefore, the applicants are the only legal heirs of deceased Purushottam Dungaji Moyal.

4] Proclamation Exh.10 was issued and published in daily newspaper "Lokopchar" dated 04.11.2022.. No objection is received to the claim of the applicants. The applicant has filed death certificate of deceased Purushottam Dungaji Moyal below

Exh.14, death certificate of the mother of applicants below Exh.15. The applicants have also placed on record verified photo copies of Aadhar cards of applicant No.01 and 2 at Exh. No.16 and 17. The copy of Newspaper Exh.19 and its bill at Exh.18. The applicant No.02 has filed her evidence affidavit at Exh.13. The evidence of applicant remains unchallenged. The applicant also file her evidence close purshis at Exh 20. It appears from the evidence on record that the applicants are the only legal heirs of deceased Purushottam Dungaji Moyal. Therefore, there is no impediment to grant heir-ship certificate in the name of the applicants. Hence, I pass the following order.

ORDER

- 1] Application is allowed.
- 2] It is declare that, the applicants are the only legal heirs of deceased Purushottam Dungaji Moyal.
- 3] Issue Heir-ship Certificate accordingly in the name of applicants after depositing requisite stamp duty.
