DECREE

Claims: Suit for Recovery of loan
Suit valued at ₹6,80,590/-

THIS suit coming on this the **29th day of May, 2026** for its final disposal before this Court in the presence of Learned Counsel Shri Bhupendra Giri for the Plaintiff and Ld. Counsel Ms. Tashi Doma Bhutia for the Defendant (*through video-conferencing*). It is ordered and decreed that the Plaintiff is entitled to recover a sum of ₹6,80,590/- (*Rupees Six Lakhs Eighty Thousand Five Hundred and Ninety*) only, with interest at the rate of 9.2% per annum from the date of filing of the suit i.e. 17.12.2022 till full and final realization of the decreed amount which shall be paid by the Defendant to the Plaintiff. The Plaintiff is also granted decree for a sum of ₹ 10,209/- (*Rupees Ten Thousand Two Hundred and Nine*) only, to be paid by the Defendant to the Plaintiff towards the Court fee deposited by the Plaintiff.
