**Fresh transfer petition has been received. It be checked and registered, as per rules.**

This is an petition u/s 448 BNSS for transfer of the a  
Criminal Case case bearing No. 1501/2020 titled 'State Vs.  
Devender Kumar' FIR no. 280/2019 PS Prashant Vihar, pending  
adjudication before the court of Sh. Rohit Kumar, Ld. JMFC-04,  
North, Rohini to some other court of competent jurisdiction.

Arguments heard.

The Ld. Counsel for the petitioner submits that FIR  
No. 280/2019 was registered u/s 506/509 IPC at PS Prashant  
Vihar and after completion of investigation, final report / charge-  
sheet was filed in the court of Ld. JMFC-04, North, Rohini  
Courts, Delhi where charges u/s 506/509/294/354A/354 IPC have  
been held to be prma facie made out vide order dated 24.02.2026  
by Ld. JMFC-04, North, Rohini, Delhi. It is submitted that the  
matter may be transferred to Ld. Mahila Court, North District,  
Rohini for trial in view of the nature of allegations and charges  
u/s 354/354A IPC. Ld. Adll. PP for the State fairly concedes that  
in view of the allegations against the accused the trial should be  
conducted by the concerned Mahila Court.

Considering the submission of Ld. Counsel for the petitioner/ accused, the Criminal case bearing No. 1501/2020 titled 'State Vs. Devender Kumar' FIR No. 280/2019 PS Prashant Vihar, pending adjudication before the court of Sh. Rohit Kumar, Ld. JMFC-04, North, Rohini is hereby withdrawn and is transferred to the court of Ms. Sanya Dalal, Ld. JMFC (Mahila Court-01), North District, Rohini, Delhi for disposal as per law. The transfer petition is accordingly allowed.

Parties concerned are directed to appear before the transferee court on **18.03.2026 at 10.00 am** for further proceedings.

Ahlmad of the court concerned is directed to send the case file, complete in all respects, to the transferee court, well in time.

Copy of this order be sent to both the concerned courts, for intimation and necessary compliance.

Transfer application/petition be consigned to Record Room, after completing necessary formalities.
