ORDER BELOW EXH. 1 IN C.C. NO. 6802286/PS/2021
(NDPS No.44/2021)

Today MHB Colony Police Station has filed the Charge-sheet against the accused for the contravention of section 8(c) of the N.D.P.S. Act punishable under section 27 of the said Act.

The particulars of the offence is read over and explained to the accused. He pleaded guilty. I have verified that his plea is voluntary. Hence I accept the same.

Heard the accused on the point of sentence. The accused prayed for leniency. Taking into consideration the nature of offence, age of the accused in my view following sentence will meet the ends of justice. Hence, I proceed to pass following order.

ORDER

3. The accused is informed about his rights of appeal.
