Pursuant to the directions contained in letter dated 20.09.2020 of the Hon'ble High Court of Delhi and circular No.38955-39010/PD&SJ Sectt./COVID/North/RC/2020 dated 27.11.2020, the undersigned is also holding physical hearing in the Court today.

As per order of Hon'ble Delhi High Court bearing no. 26/DHC/2020 dated 30/07/2020 and subsequent order of both Id. District & Sessions Judge, North-West & North, Rohini Courts Delhi bearing no. D&SJ/Sectt (N & NW)/RC/2020/28337-28426 dated 03/08/2020, all the Courts functioning in North-West District & North District, Rohini Courts Complex, shall henceforth take-up all the cases listed before them through videoconferencing from 10.00 AM onward. However, evidence shall be recorded only in ex-parte and uncontested matters where the same is required to be tendered by way of affidavit. Further as per subsequent order of Hon'ble Delhi High Court bearing no. 249/RG/DHC/2020 dated 06/08/2020, no adverse order is to be passed in non-urgent/routine matters where the concerned advocate/litigant is unable to join the proceedings through videoconferencing till the time of the normal functioning of the Courts is resumed.

: None for accused persons.

The present matter is fixed for filing of written arguments/arguments on the point of charge. None has appeared on behalf of accused persons.

Written explanation qua non-compliance of order dated 11.12.2020 not filed by the IO.

Status report regarding FSL result filed on behalf of SI Rinku Bhakar wherein it is mentioned that the result on Arms Act has not been received so far from FSL and a priority letter has been sent to FSL on 16.12.2020 in this regard.

IO has not appeared despite specific directions in terms of previous order dated 11.12.2020. He is required to furnish written explanation as to why the contempt proceedings be not initiated against him for willful default of the previous order.

Further, IO is directed to appear in person on the next date of hearing and apprise this Court about status of FSL result as well as sanction u/s 39 Arms Act and file his detailed explanation.

Put up for appearance of IO and for further proceedings on 08.01.2021. Let copy of this order be sent on the email/ whatsapp of the Id. counsel for the accused persons and Id Substitute Additional P.P for State.

Court notice be also issued to Director FSL for next date of hearing with directions to prepare FSL report on priority basis.
