The case is fixed for filing of FSL result, sanction u/s 39 Arms Act as well as for consideration of bail application u/s 439 Cr.P.C. of accused Manoj @ Chotu @ Toni and application moved on behalf of accused Harsh @Deepak @ Joni seeking high risk guard.

Pursuant to previous order, Ms. Perna Lakara, SSA (Ballistics), FSL Rohini, Delhi, is present on behalf of Director (FSL) and has filed letter no. 391/DFSL dated 22/03/2021 of Ms. Deepa Verma, Director, FSL, wherein it is mentioned that FSL report is ready in the present case and request for exemption has been made on behalf of the Director, FSL. In view of the same, Director, FSL, is exempted for today only. **Issue notice to concerned IO to collect the FSL result and to file the same before the Court and also to obtain sanction u/s 39 Arms Act and file before the Court on next date.**

Pursuant to previous order, a letter has been received from Dy. Superintendent, District Prison, Jhajjar, wherein it is mentioned that he has no objection if accused Harsh @ Deepak @ Joni is transferred from Jhajjar Jail to District Jail Rohini, Delhi, since the said accused is having 01 case of Jhajjar division and 06 cases of Delhi and earlier also, this accused was in Rohini Jail.

Similarly, a letter has been received from Dy. Superintendent, Central Jail no. 10, Rohini, that rival groups are lodged in the said jail and there is a possibility of mishappening and still if this Court pass direction for transfer of accused Harsh @ Deepak @ Joni to said Jail, they have no objection in accommodating the said accused in Central Jail no.10, Rohini, Delhi.

Ld. Counsel for accused Harsh @ Deepak @ Joni has submitted that since the said accused was earlier in Central Jail no. 10, Rohini, is having threat to his life during his production from District Jail Jhajjar to Rohini Court & the State incurs heavy expenditure on the production of

said accused District Jhajjar to Rohini, therefore, he may be transferred to Rohini Jail. He has further submitted that he shall move an application for permanent exemption of said accused on next date of hearing and that said accused may be provided security in case he is transferred to Rohini Jail.

In view of the aforesaid submission, accused Harsh @ Deepak @ Joni is ordered to be transferred from District Prison Jhajjar to Central Jail no. 10, Sector-19, Rohini, Delhi. It is further directed that the said accused be provided security as per rules while his transfer to said jail at Rohini. A copy of this order be sent to Superintendent District Prison, Jhajjar as well as to Central Jail no. 10, Rohini, Delhi, for information and compliance.

Bail application of accused Manoj @ Chotu @ toni (A-3) is adjourned for next date of hearing.

Put up for arguments on charge as well as for consideration of aforesaid bail application and filing of FSL result & sanction u/s 39 Arms Act on **31/03/2021**.
