As per latest order of Hon'ble High Court vide no. 439-470/RG/DHC/2021 dated 22.07.2021 & subsequent order no. 22091-221-45/Judl/North/RC/2021/Judl/North/RC/2021 dated 22/07/2021 of Id. Principal District & Sessions Judge, North, Rohini Courts, Delhi, all judicial officers shall endeavour to take up all matters of their respective Courts through videoconferencing w.e.f. 24.07.2021 to 13.08.2021. The Weblinks of all the courts shall remain functional throughout the working-hours.

File taken-up today as **this urgent application seeking directions/order to concerned DCP 3rd Bn and in-charge Rohini Jail lock-up for providing appropriate security to prevent mishappening likely to happen in future moved on behalf of accused Harsh @ Deepak @ Joni** is placed before me since the regular matter is pending before this Court. It is submitted by Id. Counsel for the applicant/accused that applicant/accused is the prime accused in the present matter as well as involved in other 6-7 heinous criminal cases which are pending against him. He has further submitted that accused Harsh @ Deepak @ Joni s/o Padam Singh is also in judicial custody in 201/20, PS Dujjana (Jhajjar), Haryana, u/s 302/34 IPC and as per information he is still in judicial custody at Rohini Jail, Delhi. He has further submitted that as per records, in the aforesaid case, deceased who was shot dead in the incident was brother of Neeraj Bawana and was active member of his gang & as per prosecution, the applicant/accused is active member of Neetu Dabodia/Ashok Pradhan gang and is having multiple gang rivalries with other gangs and there is serious threat to his life during court visit and "*mulaqats*" and there are numerous co-prisoners who are active members of anti rival gangs. He has further submitted that in the year 2015, the cousin brother of the present applicant namely Pradeep @ Bhola was killed in jail van, Rohini, Delhi by the active members of Neeraj Bawana gang and is therefore having serious threat and direct rivalry with the other gangs. Id. Counsel has further submitted that in view of the reply filed by the Rohini Jail authorities, which is clearly mentioned in order dated 23/03/2021 that the applicant is having serious threat to his life during the production before the Courts in Delhi and Haryana. He has further submitted that present applicant/accused is continuously receiving serious threats of his murder during court visit on production. He has further prayed that DCP 3rd Bn and in-charge of Rohini Jail Lock-up may be directed to provide appropriate security as well as videography to prevent any incident likely to happen
