from rival gangs. Ld. counsel for accused Harsh @ Deepak @ Joni (A1) and Rahul (A-5) has also submitted that both these accused are also having apprehension of threat to their life from rival gangs and as such necessary directions may be given to the concerned Jail Superintendent to produce the said accused persons through videoconferencing only, until and unless there is requirement of production of them before the Court as well as to Lock-up Incharge, Rohini Courts, Delhi, that in case the said accused are produced from J.C. in Lock-up, they may be produced through videoconferencing only and in case their appearance is very much necessary before the Court, then they may be produced with proper security in Court.

Heard. Keeping in view the fact that accused Harsh @ Deepak @ Joni (A1), Pradeep @ Bhagat @ Monu (A4) and Rahul are apprehensive of an attack during court hearings by Neeraj Bawana and Naveen Bali Gang, **the concerned Jail Superintendent(s) is/are directed to produce the said accused persons through Jail videoconferencing till further orders.** The application of accused Pradeep @ Bhagat is disposed of accordingly.
