First application has been moved on behalf of Manoj @ Toni seeking his medical treatment. Reply to the afore-mentioned application along with medical documents has been filed on behalf of Deputy Superintendent, Central Jail No-8/9, Tihar, Delhi. Same be taken on record. Let the concerned Medical Officer be directed to join the Court proceedings through VC on NDOH. Let complete medical record be also filed through dedicated e-mail of this Court on NDOH.

Second application has been moved on behalf of Pradeep @ Bhagat @ Monu for deputing SAG in security while in transit from jail to Court and back on the ground that he has security threats from his viral gangs. Reply to the afore-mentioned has been received from concerned Jail Superintendent wherein it is mentioned that request of the UTP was forwarded to DCP, 03rd Battalion for taking necessary action and a reply from the office of concerned DCP was received whereby the said request was declined in view of day by day increase of court production and other reasons. In view of the same, second application is disposed off as dismissed.

Notice issued upon IO / SI Gajender received back duly, however, he is absent despite service of same and repeated calls since morning. Let B/W be issued against IO / SI Gajender in the sum of Rs.5,000/- with one surety in the like amount through SHO concerned, returnable for NDOH.
