ORDER:

1. This order of mine shall dispose of Ist bail application U/s 439 Cr.P.C filed on behalf of accused/applicant for grant of bail.
2. The applicant/accused has filed the present bail application with the averments that applicant/accused is an innocent person and he has been falsely implicated in the present case. It is further alleged that applicant/accused was arrested in the present case on 9.7.2022 and since then he is in judicial custody. Hence this bail application.

3. Upon notice issued to State, learned Addl.PP for the State appeared. Main trial Court file, which is pending before this Court, has been received.

4. I have heard learned Counsel for applicant/accused and learned Addl.PP for the State and gone through the file very carefully.

5. Perusal of file shows that accused/applicant is in custody since his arrest on 9.7.2022. In this case, FIR was got registered by Amrinder Singh son of Jarnail Singh, who is brother of deceased Jaswinder Kaur. The applicant is husband of deceased Jaswinder Kaur. Initially, FIR was registered, when, Amrinder Singh has suffered statement on 4.7.2022, when he came to know about death of his sister Jaswinder Kaur and this FIR was registered against Harbhajan Singh, Jaswant Kaur, father-in-law and mother-in-law of deceased, Mandeep Kaur and Ravinder Kaur, sisters-in-law of deceased Jaswinder Kaur. The applicant was not named in the FIR. Subsequently, supplementary statement of Amrinder Singh was recorded on 6.7.2022 stating that under depression, he could not name Jagwinder Singh to be the person, who is also involved in commission of crime and his name has been added in the FIR. He was arrested on 9.7.2022. In the inquiry and thereafter in investigation also, Harbhajan Singh, Jaswant Kaur, Mandeep Kaur and Ravinder Kaur have been declared innocent and challan against Jagwinder Singh has been presented. If we go to allegations in the FIR, then, there is no allegation of abetment committed by the applicant, resulting into commission of suicide of Jaswinder Kaur, his wife. The trial of the case will take long time. So, no useful purpose would be served by keeping applicant/

accused behind bars for indefinite period. Thus, in view of above discussion, present bail application of applicant/accused is allowed and applicant/accused is ordered to be released on bail subject to his furnishing personal bonds in the sum of Rs.One Lac with one surety in the like amount subject to the following conditions:

1. That applicant/accused shall appear in the court for each and every date of hearing.
2. Applicant/accused will not tamper with the prosecution evidence.
3. Accused/applicant will not leave the country without prior permission of the court.

Trial court file be returned forthwith. The record of present bail application be attached with the main file.
