ORDER BELOW EXH.87:-
(Extension in Temporary Bail)

1. Applicant has filed the present application seeking extension in temporary bail upto 02.1.2023 granted to him vide order 15.12.2022 passed in Cri. Misc. Application No.8720/2022.
2. Learned Advocate for the applicant has made submission that applicant has been released on temporary bail by the Hon'ble Court vide order dtd.15.12.2022 passed in Cri. Misc. Application No.8720/2022 upto 23.12.2022, but, as his wound has not been recovered yet and to get further treatment at home so that the applicant could not get any infection, he has requested to release the applicant on temporary bail upto 02.01.2023 as prayed for in the application.

3. Learned A.P.P. for the State has submitted that considering the facts and circumstances of the case and medical papers, appropriate order be passed as the Hon'ble Court deems fit.
4. After considering the rival submission of both the sides and on perusal of the record of the case, it appears that earlier, applicant has filed various Cri. Misc. Applications seeking temporary bail and the same have been granted as per the orders passed therein and lastly, this Court has granted temporary bail to the applicant/accused vide order dtd.15.12.2022 passed in Cri. Misc. Application No.8720/2022 upto 23.12.2022 on the humanitarian ground and the present application is to extend the said temporary bail upto 02.01.2023. Thus, considering overall facts and circumstances of the case, present application is hereby granted on the humanitarian ground only. Accordingly, the following order is passed.

ORDER

This application is hereby **allowed** and **temporary bail granted to the applicant vide order dtd.15.12.2022 passed in Cri. Misc. Application No.8720 of 2022**, is hereby **extended upto 02.01.2023**.

Conditions imposed if any vide order dtd.04.10.2022 passed in Cri. Misc. Application No.6987 of 2022, be remained as it is.

The applicant/accused has to **return to the jail by 5.00 p.m. of 02.01.2023** failing which concerned authorities are hereby permitted to take appropriate action against the present applicant.

This order be intimated to the concerned Authorities and Court if any, for information and necessary action.
