Vide letter dated 22/03/2022, Superintendent, District Jail Sonipat (Haryana) has requested for passing appropriate order to detain/lodge accused Deepak s/o Jawahar and Bharat Bhushan s/o Jai Pal in District Jail Rohini since both the said accused, who were admitted in District Jail Sonipat on 22/10/2018 in case FIR no. 398/2017, u/s 341/379B/302 IPC, PS Kundli (Sonipat) & have been acquitted in the said case vide order dated 17/03/2022 by the Court of Sh. Rahul Bishnoi, Id. ASJ, Sonipat and no other case is pending against them in Haryana State at present and presently they are facing trial in the present case.

Pursuant to previous order, reply has been received from Superintendent of Prison, Central Jail No.3, Tihar, New Delhi, that if both the aforesaid accused are no more required to be detained in Haryana, then they may be shifted/transferred to said jail to be lodged to face trial in their Delhi cases.
