Present: As above.

Ld. Counsel for applicant/accused submits that applicant/accused is in JC since 14.05.2025 and he has been falsely implicated in the present case. It is further submitted that there is no CCTV footage or eye witness against the applicant/accused in the present matter to prove the presence of applicant/accused at the place, date and time where the alleged incident took place. It is further submitted that alleged weapons are planted by the police officials in connivance of the complainant and his father who himself presented the alleged weapons and t-shirt of complainant before IO in PS beyond reasonable time i.e after 2 days of incident. It is further submitted that no recovery has been affected from or instance of the applicant/accused. It is further submitted that in the present case co-accused Bharat Kumar Mehra has already been granted bail. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

It has been argued on behalf of complainant that complainant has serious threats of his life from applicant/accused **Sameer Ali** and if the present bail application is allowed, applicant/accused **Sameer Ali** shall definitely cause harm/threaten complainant and other material witnesses. It is also informed by Ld. Counsel for complainant that two previous bail applications moved on behalf of applicant/accused **Sameer Ali** have been dismissed by Ld. Sessions Courts. Copy of the same are placed on record. It is prayed that the present bail application may kindly be dismissed.

This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, the present FIR bearing no. 330/2025 has been registered at PS Bhalaswa Dairy U/s.109(1)/3(5) BNS with the allegations that applicant/accused **Sameer Ali** alongwith his co-accused person, in furtherance of their common intention, caused multiple injuries on the person of Nishan with iron pipe and stick, as a result of which he sustained multiple injuries on his vital parts i.e. head & other parts of the body. Perusal of the file shows that present case is at initial stage and charge has not

been framed as yet. Further, eye-witnesses are yet to be examined. Releasing applicant/accused **Sameer Ali** may cause serious threats to the eye witnesses/complainant.

Keeping in view of seriousness of allegations leveled against applicant/accused **Sameer Ali** and gravity of offences alleged against him, the **present bail application of applicant/accused is hereby dismissed.**

Nothing stated herein shall tantamount to any expression of opinion the merits of the case. **Copy of order be given dasti to the applicant/accused.** The present bail application be tagged with the main case file.
