As per order of Hon'ble Delhi High Court bearing no. 26/DHC/2020 dated 30/07/2020 and subsequent order of both Id. District & Sessions Judge, North-West & North, Rohini Courts Delhi bearing no. D&SJ/Sectt (N & NW)/RC/2020/28337-28426 dated 03/08/2020, all the Courts functioning in North-West District & North District, Rohini Courts Complex, shall henceforth take-up all the cases listed before them through videoconferencing from 10.00 AM onward. However, evidence shall be recorded only in ex-parte and uncontested matters where the same is required to be tendered by way of affidavit. Further as per subsequent order of Hon'ble Delhi High Court bearing no. 249/RG/DHC/2020 dated 06/08/2020, no adverse order is to be passed in non-urgent/routine matters where the concerned advocate/litigant is unable to join the proceedings through videoconferencing till the time of the normal functioning of the Courts is resumed.

Put up for arguments on the point of charge as well as on the pending bail application of accused Suresh Gillu on **13.01.2021**, the day of physical hearing of the Court.
