The present case pertains to immovable property. Sh. Ram Khilawan has filed the present case against me. I have purchased property from one Vijay Kumar. When I started the construction, Ram Khilawan tried to stop me to raise any

construction and he called at 100 number. Thereafter, police came at the spot and we reached at PS but Ram Khilawan did not reach at the PS. It appears that Ram Khilawan has filed the above said case for the above said reason with regard to property in question.

I have not filed any case against Ram Khilawan regarding the property in question. I do not have the chain of documents pertaining to the previous owners. Vijay Kumar might have purchased the property from his father. I do not know any person by the name of Kanhiya Lal and Bachchan Singh. At the time of purchase of property from Vijay Kumar, I have received '*Fard*' from Vijay Kumar. I have received only Power of Attorney from Sh.
