Vide the present application, the applicant/owner is seeking release of mobile phone make VIVO Y11, Colour Blue, on superdari, on the ground that he is in need of the said mobile and is ready to abide by all the terms and conditions which may be imposed by the Court, while releasing it on superdari and has undertaken to produce the same before the Court as and when directed. Along with the application, photocopy of bill of the mobile is also annexed. Keeping in view the aforesaid submissions, **the mobile phone make VIVO Y11, colour Blue, is ordered to be released to its owner namely Jag Prasad on his furnishing superdariname in the sum of Rs 10,000/- to the satisfaction of the concerned IO/SHO, on proper identification and against acknowledgment. However, the applicant/owner is directed not sell the said mobile phone without the prior permission of the Court and to produce the same before the Court as and when required. The concerned IO/SHO is directed to take photographs of the mobile phone before releasing the same to applicant/owner on superdari and file the same before the Court along with the CD of the photographs. The application is disposed of accordingly.**
