Reply to the bail application has been received from IO.

Ld. counsel for applicant/accused submits that applicant/accused is in JC and he has been falsely implicated in the present case. It is further submitted that applicant/accused is victim in case FIR No. 386/2020 PS Jahangir Puri and in this case applicant/accused received major injuries and he is still undergoing treatment for those injuries. It is further submitted that chargesheet has already been filed and trial will take a long time as thirty one witnesses are yet to be examined. It is further submitted that applicant/accused is 21 years old and he is only the sole bread earner of his family and in his family only three sisters and old aged parents. It is prayed that applicant/accused may be granted interim bail. Ld. counsel for applicant/accused has filed judgments i.e **Angad Kumar @ Sagar Vs. State (Govt. of NCT of Delhi) Bail Application no.**

On the other hand, Ld. Additional PP for State strongly opposed the interim bail application and submits that allegations against the applicant/ accused are serious in nature. It is further submitted that applicant/accused Ankit shot at Rohit, who collapsed on the spot. It is further submitted that applicant/accused has furnished old medical documents and currently he is not undergoing any medical treatment and prayer is made out for dismissal of the bail application.

Medical report of applicant/accused has been received from Superintendent, Central Jail No. 4, Tihar, New Delhi along with the report of Medical Officer In-charge, Central Jail No. 04, Tihar, New Delhi. Medical officer Incharge submitted that the applicant/accused has been examined as he had alleged head pain. He has further submitted that nothing serious so far been found, though accused/applicant is also going to be examined by orthopedic surgeon. it was further submitted that the alleged knife injuries sustained by the applicant/accused in the year 2020 have already been healed.

Keeping in view of the fact that and circumstances of this case and also considering the submissions of Medical Officer Incharge , Central Jail No. 4 as there is no urgency for treatment and
