An application has been moved by ld. counsel that IO Insp. Varun Dalal is present on 28.04.2023 and submitted about the Hon'ble High Court proceedings dated 27.04.2023 but his presence was not marked in the order dated 28.04.2023. IO present in the court today also submitted that his presence was not marked in the said order.

Heard. Perused.

Perusal of the order-sheets dated 28.04.2023 reveals that inadvertently his presence was not marked in the said order although he was present on the said date.

It is submitted by ld. counsel that the Hon'ble High Court of Delhi has ordered for framing of schedule for examination of witnesses in the present case but he has not placed on record the certified copy of said order. IO present in the court today has affirmed the said fact that the Hon'ble High Court has directed to frame schedule of examination of witnesses. This court has also not received the copy of said order. Therefore, **Ld. counsel is required to file the**

It is submitted by ld. counsels that CCTV footage cannot be played in the absence of certificate u/s 65B of Indian Evidence Act and unless the relevant witness has been called.

Ld. Addl. PP for the State has requested that the relevant witness regarding CCTV footage may be called on the next date of hearing.

PW3 Sh. Fateh Singh Chauhan has been examined-in-chief, cross-examined and discharged.

PW Aditya is also present but he is discharged unexamined for today only as relevant witness of CCTV footage has to be examined prior to his cross-examination.

Summons issued to PW Dheeraj received back served upon his father but he is absent.

Put up for RPE on 02.08.2023. Issue summons to PW Ravi for further examination, witness related to CCTV footage mentioned at serial no. 14 and PW Aditya be summoned for the said date.
