PW-4 Sh. Than Singh is present, examined in chief,
cross examined by ld. counsels for accused persons and discharged.

PW-5 Master Aditya is present. On examination of this
witness, court is satisfied, the witness is capable for understanding the
questions and to give rationale reply thereto. PW-5 Master Aditya is
partly examined in chief and his further examination in chief is
deferred as the assistance of IO is required for playing the CCTV
footage.

At this stage, Ld. counsel for accused Ankit @ Dudhiya
has moved an application wherein he has made objections with respect
to playing of CCTV footage without FSL and Certificate U/s. 65B of
Indian Evidence Act. Same is kept pending for the next date of
hearing.

PW-1 Ravi is present. Perusal of the file shows that his
examination in chief is also deferred for playing the CCTV footage,
therefore, he is also discharged unexamined for today only.

In view of the same, PW-1 Ravi and PW-5 Master

Aditya are bound down for the next date of hearing.

No other PW is present.

Notice be issued to IO with the direction to appear in person and to make arrangement for playing the CCTV footage on the next date of hearing.

At this stage, Ld. counsel for accused Ankit @ Dudhiya has pointed out that calender may be prepared in the directions of Hon'ble High Court of Delhi. However, he has been informed the same may be prepared after completion of examination of PW 1 & PW 5.

At this stage, Ld. counsel for accused Raju has moved an application for cancellation of surety bonds furnished by sureties of accused Raju during the period of his interim bail as well as for release of original RC.

Submissions heard. Record perused.

As accused Raju has already surrendered before the concerned Jail Authorities and he has been produced from JC today in the court, no useful purpose shall be served by keeping the documents of sureties. Surety bonds furnished by surety of accused Raju stands cancelled. Documents, if any be returned to the sureties after acknowledgement.

Be put up for remaining PE on **26.08.2023**. **Shortest possible date is given keeping in view of the fact that one of the witness is minor boy having age of 15 years.**
