File taken up today on an application for grant of interim bail moved on behalf of applicant/accused **Ankit Dudhiya**.

Present: Sh. Kumar Sanjay, Ld. Addl. PP for the State.
Sh. Vaibhav Trivedi, Ld. Counsel for applicant/accused.
Jail Superintendent and Medical Officer Incharge from Rohini Jail appeared (**through VC**).

Ld. counsel for applicant/accused submits that applicant/accused is unwell and requires immediate medical attention. It is further submitted that applicant/accused is suffering from paralysis in his hand and requires immediate surgery. It is further submitted that medical report of the applicant/accused is annexed with the application. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, the present FIR bearing no. 596/2021 has been registered at PS Jahangir Puri U/s. 302/120B/34/201 IPC & U/s. 25/27/54/59 Arms Act. Medical Status Report was called from

Medical Officer through Jail Superintendent concerned. Perusal of the Medical Status Report shows that applicant/accused **Ankit Dudhiya** was given date of surgery on 14.05.2024 by St. Stephen's Hospital , but he refused for surgery and since then he has been denied for surgery. Further, at present general medical condition of applicant/accused **Ankit Dudhiya** is stable and all prescribed medicines are provided to him. Jail Superintendent as well as Medical Officer Incharge have joined the court proceedings through VC and they have reiterated the similar facts as stated in the Medical Status Report. In view of the status report filed by Medical Officer, CJ-10, it appears that present application has been moved without any merit, **same is dismissed accordingly.**

Nothing stated herein shall tantamount to any expression of opinion the merits of the case. **Copy of order be given dasti to the applicant/accused Ankit Dudhiya.** The present interim bail application file be tagged with the main case file.
