I got married on 07.12.1996. My husband is labour by profession. My matrimonial home is at aforesaid address. I do not

know the exact area of my matrimonial home. Although, it is owned by my husband. I am residing at the aforesaid address with my husband and two children. My husband have two brothers and one sister. My matrimonial home belongs to my father in law. There is no partition suit filed by my sister in law against my husband. My father spent along Rs.60,000 – 70,000/- in my marriage. The suit property measuring about 137 Sq. yards. I do not know the market value of the suit property at the time of my marriage or at present. I used to visit suit property to meet my father as and when I wish to meet specially on festival occasions (5-6 times in a year). I never demanded during the lifetime any money from my father. My father never sold the suit property to any person. It is wrong to suggest that the suit property is already purchased by my brother from my father. Voltd. My father never sold suit property at any point of time to my brother.
