As per office order no. 700/RG/DHC/2021 dated 30/09/2021 & subsequent order no. 29459-29518/PD&SJ Sectt./COVID/North/RC/2021 dated 30/09/2021 of Id. Principal District & Sessions Judge, North, Rohini Courts, around 3/4 th of the total strength of judicial officers shall hold the court physically, while the others shall hold through virtual mode w.e.f. 05/10/2021 to 30/10/2021.
