Examination in chief by the ld. AGP Shri. V.V. Deshpande for State

01. On 31/01/2022, I was in Vivekanand Chowk. Manulla, ASI called me there for preparation of panchanama. Uttam Kasale was another panch. PSI Manulla, myself and Uttam Kasale went to Annabhau Sathe Vidyalaya, Latur for panchanama. Sambhaji Maske and his son showed us the spot of incident. After this, we all went to the school. Giri Maharaj, Peon was present there. He told us that not to enter the school. He started to abuse all of us. PSI Manulla told him that they came there for panchanama. He told to PSI Manulla not to prepare panchanama there and go out of school. Due to the shouts, all the employees came there. Those employees means Munde Sir, Jadhav Clerk, Pandhavle, grandson of President Narsinghe, brother of Head Master Kundlik Narsinghe etc. All these persons told to PSI Manulla that they will go to Superintendent of Police and will dismiss him. As the accused obstructed us to prepare panchanama, we could not prepare it and returned to the police station. All the accused (except accused. no. 3) present before the Court. The police recorded my statement as per my say.

Cross Examination by the ld. Adv Shri. A.G. Jadhav for the Accused

02. Since last 40 years, I resides in Sant Goroba Society, Latur. Sambhaji Maske also resides there. Since last 30 to 35 years he resides there. It is not true that Sambhaji Maske is my relative. Before the incident he was not my relative, however now he is my relative. Before the incident, I was knowing Sambhaji Maske. I do not know whether Sambhaji Maske works with the political party. The daughter-in-law of Sambhaji Maske was councilor of our residential area. Laxman Maske came with me in the Court today. Laxman Maske is also witness in this case.

03. There are residential houses surrounding to the spot of incident. It is not true that the spot is of heavy traffic. 10 to 15 persons might have gathered on the spot. It is not true that I am knowing PSI Manulla prior to the incident. I met to PSI Manulla at 1.30 p.m. on the day of incident. The incident lasted for one hour.

04. Before the incident I had not gone to the school. I again say that I used to go to school on the day of Independence Day. I know all the accused prior to the incident. The dispute in respect of the society of the school is going on in the Court. I do not know whether there are groups of Sambhaji Maske and Narsinghe. Uttam Kasbe resides in our society since 20 years. I do not know when the disputed panchanama lateron prepared. After two days, I was called in the police station. My signatures were obtained in the police station. It is not true that to help

Sambhaji Maske I am deposing false against the accused. It is not true that I am deposing false.
