ORDER

2. I heard him on the point of sentence. He prayed for leniency. Thus considering the punishment provided by this section and submission of accused, in my view following punishment will suffice the purpose. Thus following order

ORDER

1. The accused is hereby convicted on admission of the offence punishable under section 12 (a) of Prevention of Bombay Gambling Act, vide provision of section 252 of Cr.P.C.
2. The accused is sentenced to suffer S.I. till rising of court and pay fine of Rs. 300/- (Rs. Three Hundred Only) in default to suffer S.I. for one day.
3. Seized amount of Rs.235/- (Rs. Two Hundred Thirty Five only) be credited to Government and other gambling articles being worthless, be destroyed.
