Principal District & Sessions Judge, North, Rohini Courts, Delhi.

Ld. Counsel for applicant/accused submits that applicants/accused persons are in JC and they have been falsely implicated in the present case. It is further submitted that applicants/accused persons have no enmity with the complainant and family members except to the small heat arguments. It is further submitted that complainant son has received injury by hitting of the bricks throwing by the complainant and their companions and not by the applicants/accused persons which can be verified from the neighbours who were present at the spot. It is further submitted that there is nothing incriminating has been found/recovered against the applicants/accused persons as they

have been implicated by the police officials in this crime. It is further submitted that there is no cogent evidence on record or there nothing evidnece or object was recovered from the spo or in the possession of applicants/accused persons. It is further submitted that t It is further submitted that . It is further submitted that no application of applicant/accused is pending either before any other Court including Superior Courts. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, the present FIR bearing no. 324/2026 has been registered at PS Adarsh Nagar U/s. 109(1)/3(5) BNS with the allegations that applicants/accused persons namely **Vikas, Bhagwan Singh, Jeetu & Munesh**, in furtherance of their common intention, made an attempt to murder victim Vicky by

hitting his head with bricks. As per reply filed by IO, victim has sustained fracture on his head and he remained admitted in hospital for around 20-25 days. Injuries have been caused on the vital parts of the body of victim. Investigation of the present case is at initial stage.

Keeping in view of above discussion as well as seriousness of allegations leveled against applicants/accused persons namely **Vikas, Bhagwan Singh, Jeetu & Munesh** and gravity of offences alleged against them, the **present bail applications of applicants/accused persons are hereby dismissed.**

Nothing stated herein shall tantamount to any expression of opinion the merits of the case. **Copy of order be given dasti to the applicants/accused persons.** The present bail application files be consigned to record room.
