

**IN THE COURT OF SPECIAL DESIGNATED JUDGE FOR
SPEEDY TRIAL OF SERIAL BOMB BLAST CASES,
AT AHMEDABAD**

Sessions Case No.38 of 2009 and others

Order below Exh. 417.

Heard learned Special P.P. Mr. Amit Patel who is present before the Court.

1. Police Officer Mr. Ramlal Brijlal Aarmo, Sub Divisional Officer Police from Madhya Pradesh Police is before the Court with a written request to permit him to interrogate **accused No.26 - Mohammedali alias Jamal alias Ziya alias Yasar alias Abubakar Mahramali Ansari** at present in prison in Central Jail, Sabarmati, Ahmedabad in this matter.

It is submitted that there is one F.I.R. No.399/08 filed in District Narsinghpur, Madhya Pradesh which needs to be investigated and with a view to investigate the said offence, he is required to interrogate **accused No.26 - Mohammedali alias Jamal alias Ziya alias Yasar alias Abubakar Mahramali Ansari.**

2. Having perused the application and accompanying documents, it is just and proper to permit the Police Officer which seems necessary in larger interest of justice, but since there is no provision for formal arrest such permission cannot be granted.

3. In light of the foregoing discussion following final order is passed :

ORDER

(1) The application is partly granted with the following conditions :

- (a) Police Officer Mr. Ramlal Brijlal Aarmo from Madhya Pradesh Police shall only interrogate **accused No.26 - Mohammedali alias Jamal alias Ziya alias Yasar alias Abubakar Mahramali Ansari** for one hour only, only on the day. One hour shall begin with the time he is permitted by the Central Jail Authority to interrogate the prisoner.
- (b) Police Officer Mr. Ramlal Brijlal Aarmo from Madhya Pradesh Police shall only interrogate **accused No.26 - Mohammedali alias Jamal alias Ziya alias Yasar alias Abubakar Mahramali Ansari** with reference to the F.I.R. No.399/08 filed at District Narsinghpur, Madhya Pradesh he has attached along with the application.

(c) He shall act in strict compliance with Jail's rules and regulations and is required to take necessary administrative permission by observing all necessary formalities with the Central Jail, Sabarmati, Ahmedabad.

(2) The prayer for formal arrest of the accused is rejected as there is no such provision in law.

(3) This application stands disposed of as partly allowed.

(4) Yadi of this order be sent to Central Jail Sabarmati, Ahmedabad.
