exams and it will cause unnecessary burden of expenses on the State since extra escort has to be sent alongwith the applicant/accused, to which it is submitted by Id counsel for applicant/accused that in case custody parole is granted to the applicant/accused, the applicant is ready to incur expenses of Rs. 20,000/- and prayed that rest of the expenses may be born by the State.

Heard. Keeping in view the fact that exams of the applicant/accused is going to commence w.e.f 20.11.2021 and the last exam of the applicant/accused is scheduled for 10.12.2021. The exam time of the applicant is at 1.30 p.m to 5.30 p.m. Accordingly the applicant/accused is granted custody parole for 20.11.2021, 29.11.2021, 01.12.2021, 06.12.2021 and 10.12.2021 **from 12 noon to 6 p.m** for attending his exams on the above mentioned dates in Bal Vikas Senior Secondary School, Jhajjar Road, Near Power House, S Gabad, Bahadurgarh, Jhajjar Haryana. The application is disposed of accordingly, subject to the condition that applicant/accused shall deposited the amount of Rs. 20,000/- on **19.11.2021** and rest of the expenses shall be born by the State. Copy of order be sent to the concerned Jail Superintendent for intimation and compliance alongwith copy of exam date sheet of the applicant/accused. Regular matter be put up on date already fixed i.e **20.11.2021**. Let copy of this order be sent on the email/ whatsapp of the Id. Counsel for the applicant/accused.
