**Bail Application under Section 483 of the Bhartiya Nagrik
Suraksha Sanhita (BNSS), 2023**

ORDER

Applicant/accused has filed this bail application under Section 483 Bharatiya Nagrik Suraksha Sanhita (BNSS), seeking regular bail in the above noted case.

2. The learned counsel for the applicant/accused that he has been falsely implicated in this case. He has not committed any offence.

He further submitted that recovery was made from co-accused Pratham and present applicant was falsely implicated only on the statement of co-accused Pratham. He further submitted that accused has been nominated under section 29 of NDPS Act and nothing was recovered from him. He further submitted that accused is in custody since 11.09.2024. Presentation of challan and the conclusion of trial will take time. No useful purpose will be served by keeping the accused/applicant behind the bar for an indefinite period. So, he be released on bail.

3. On the other hand, APP for the State opposed the bail application and prayed that bail application may be dismissed.

4. After hearing arguments of learned counsel for accused/applicant and learned APP for the State, I have perused the police file.

5. The allegations against the accused/applicant are that on 12.08.2024 ASI Kulwinder Kaur alongwith police party in search of bad elements was going to village Jheaur Majra then one person was sitting outside the gate of cremation ground and after seeing the police party, he threw one polythene from his pocket. ASI Kulwinder Kaur apprehended him with the help of police party and when his search was conducted, 35 gram heroin was recovered from the polythene which was thrown by him. Present accused/applicant Ravi Kumar was nominated on the statement of co-accused Pratham. Pratham from whom the recovery was effected, is already on bail. FSL report has been received. Present accused/applicant was arrested on 11.09.2024 and he is in custody. The presentation of

challan and conclusion of trial will take time. No useful purpose would be served by keeping the applicant/accused behind the bar for an indefinite period. Therefore, accused/applicant is ordered to be released on bail on furnishing of bail bonds in the sum of Rs.50,000/- with one surety in the like amount to the satisfaction of learned Illaqa Magistrate/Duty Magistrate. However, it is made clear that observation made herein above shall not be construed as an expression on the merits of main case. Police record be returned. The bail application file be attached with the remand papers.
