

**Order passed below Exh. 1 in Criminal M. A. no. 33/2025
(Rohit V/s. State)**

1] Applicant filed the application under Section 503 of BNS for return of property i.e. Maruti Suzuki Ciaz no. MH-03-BW-9236 lodged with Beed City Police Station, District Beed in CR No. 19/2025.

2] Applicant submits that he is the owner of above said vehicle. He is not accused in the present CR. The said vehicle is given by applicant to the accused on rent. The said vehicle is seized by the Beed City Police from the accused. The accused is in M.C.R. The investigation in said crime is completed. The said vehicle is lying in the Beed City Police Station in the open area. It may damage due to the change in weather conditions. The applicant is ready to furnish the bond that, he will not sell, make any changes, exchange or alienate it to any third party till the conclusion of trial of present crime. He is ready to abide conditions imposed by the Court. Hence, he prayed to allow the application.

3] Notice of the present application issued to I.O and APP. APP filed his say thereby strongly objected present application on the ground that in the present case, investigation is still in progress. If, the said property is released the possibility of selling the said vehicle cannot be ruled out. Hence, he has prayed to reject the application.

4] From the verified copy of RC book, it is revealed that the applicant is the owner of the said vehicle. It will take time to conclude the trial. The applicant is ready to furnish the bond. Considering the said fact, by imposing certain conditions, the applicant is entitled to return his property. Hence, I proceed to pass the following order :-

ORDER

1] Application is allowed.

- 2] Muddemal article i.e. Maruti Suzuki Ciaz no. MH-03-BW-9236 lodged with Beed City Police Station, District Beed in CR No. 19/2025 be returned to the applicant Rohit S/o Raju Chavan, on him executing indemnity bond of Rs. 4,00,000/-.
- 3] The applicant is directed to produce the said muddemal as and when called by the Court during the trial, as per existing condition.
- 4] He shall not transfer, sell, exchange or alienate it to any third person till the final conclusion of the trial.
- 5] He shall not change its existing status till final conclusion of the trial.
- 6] He shall not misuse the said vehicle in any other crime.
- 7] Failure to obey any of the conditions, shall be liable for rejection of the present application.
- 8] Inform concerned police station accordingly.
