ORDER

1. Earlier the accused-applicant was allowed bail in Sections-326,323,324,148,149 vide order dated 16.08.2024 and this is the first bail application of the petitioner in Sections-325/201 IPC which have been added lateron, is considered.

2. Summary of the case of the prosecution is that present case was registered on the statement of Bagga Singh to the effect that on 09.04.2024 at about 1.30 pm some unknown person knocked the door of the house of complainant and asked him to open the gate. On this, complainant opened the gate, but the said person proclaimed that they had to go to the house of some other person, but inadvertently knocked the door of the house of

complainant and both the unknown persons returned back. The complainant bolted the gate from inside and went inside his room. But after 20 minutes, again two unknown persons knocked the door of the house of complainant and when the complainant opened the gate, then Khushi armed with 'Grari' made of iron, Lovely armed with 'Kirpan', Deepak armed with 'Soti', Sunny armed with 'Kirpan', Deepu @ Gyani armed with 'Kapa' and Rahu @ Atwadi (petitioner) empty handed, along-with 10-15 persons were standing in the street. They called the complainant out of the house and started giving beatings to him in the street. Accused Khushi gave a blow with iron Grari on the right leg of the complainant; Sunny gave a blow with Kirpan towards the head of the complainant, which hit towards the left side of his head; Lovely gave a blow with Kirpan on the right shoulder; Deepak gave a blow with bludgeon towards the complainant which hit on the left vessel of the complainant; Deepu alias Gyani gave a blow with Kapa towards the head of the complainant and then petitioner picked up a brick from the street and thrown the same towards the complainant which hit on the right arm of complainant. Other persons also caused beatings to the complainant and on raising hue and cry, father of the complainant came out of the house and got him rescued from the clutches of the accused. The said persons ran away from the spot along-with their respective weapons.

3. Since the applicant has already been granted bail in Sections- 326,323,324,148,149 vide order dated 16.08.2024 and offence under Sections-325/201 IPC have been added lateron, therefore, the petitioner is directed to be released on bail on furnishing bail bonds and surety bonds in the sum of Rs.50,000/- to the satisfaction of Illaqa Magistrate/Duty

Magistrate, subject to the conditions under Section 437(3) and 439(2) Cr.P.C.

4. Copy of this order be sent to the quarter concerned. Bail application be attached with the remand papers, if any, otherwise, be consigned to the Record Room.
