COMMITTAL ORDER UNDER SECTION 209 OF CR.P.C

The P.S.I. of Kothanuru Police Station has filed the final report against the accused for the alleged offence punishable under sections 306, 504, 506 of IPC.

2. During the crime Stage, accused appeared before this court and enlarged on bail as the accused has been granted Anticipatory Bail by the LVII Addl.City Civil and Sessions Judge, Bengaluru in CrI.Misc.No.25733/2024 dated:27.08.2024. On receipt of the final report, cognizance was taken for the offence punishable under sections 30, 504 506 of IPC and as there was prima-facie grounds to proceed against the accused for the above said offence, a criminal case was registered against him for the said offence. The copy of the final report and its enclosures were furnished to the accused as contemplated under section 207 of Cr.P.C.

3. Perused the materials on record.

4. On perusal of the materials on record, it reveals that the offence punishable under Section 306 of IPC is exclusively triable by the Hon'ble District and Sessions Judge, Bengaluru. Accordingly, the case has to be committed to the Hon'ble Principal District and Sessions Judge Court, Bengaluru for trial. Accordingly, I proceed to pass the following:

ORDER

Acting under section 209 of Cr.P.C., the case is committed to the Hon'ble Principal District and Sessions Court, Bengaluru, for trial.

I.O has been directed to produce the material objects seized and reported in PF.No.123/2024 dated:24.10.2024, PF.No.84/2024 dated:23.07.2024 and PF.No. 37/2024 dated:04.04.2024 as and when called by the Hon'ble Court of Sessions.

Office is hereby directed to submit the entire records to the Hon'ble District & Sessions Court, Bengaluru and intimate the fact of committal of the case to the learned Public Prosecutor.

Accused is directed to appear before the Hon'ble District & Sessions Court, Bengaluru, as and when he is directed to do so.
