File taken up today on an application U/s. 483 BNSS for grant of bail moved on behalf of applicant/accused **Sunil Khatri**.

Reply to the above said application has been filed by IO. Same is taken on record. Copy of the same supplied to Ld. Counsel for applicant/accused.

Ld. Counsel for applicant/accused submits that applicant/accused is in JC since 02.02.2026 and he has been falsely implicated in the present case. It is further submitted that the present FIR registered on dated 09.06.2025 on the complaint of the complainant in the present case, the complainant stated two persons came on motorcycle and committed the said offence and in the present FIR two accused persons were arrested namely Sachin, Nikhil and others, who already granted in this case by the Hon'ble Court. It is further submitted that the applicant/accused is arrested by the police officials of different police station in the month of November 2025 and approx 17 cases are planted against the applicant/accused in which many cases are released and other cases the applicant/accused are granted bail. further submitted that after knowing that the IO in the present case, IO of the present case falsely arrested in the present case and planted the present case upon him. It is further submitted that investigation of the present case has been completed and he is no more required for further custodial interrogation. It is further submitted that no fruitful purpose would be served to keep the applicant/accused behind the bars. It is further submitted that no application of applicant/accused is pending either before any other Court including Superior Courts. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, the present FIR bearing no. 627/2025 has been registered at PS S. P. Badli U/s. 309(4)/317(2)/3(5) BNS. It is important to mention that complainant has failed to identify applicant/accused **Sunil Khatri** as one of the offender during Test

Identification Parade conducted before Ld. JMFC concerned. Recovery has already been effected and no further custodial interrogation is required. Applicant/accused **Sunil Khatri** is in JC since 02.02.2026. Investigation qua him has been completed. Chargesheet has been filed. Trial shall take time. Therefore, it is ordered that applicant/accused **Sunil Khatri** be released on bail on his furnishing personal bond in the sum of **Rs. 20,000/- with one surety** in the like amount **subject to the satisfaction of following conditions:-**

- (i) Applicant/accused is directed not to threaten prosecution witnesses in any manner or tamper with evidence or indulge in any other criminal activity in future;
- (ii) Applicant/accused shall not commit similar offences in future. In case, it is prima facie brought to the notice of the Court that the applicant/accused is violating the said conditions, the bail granted to him shall be liable to be cancelled on an application of investigating agency in this regard.

The bail application is disposed of accordingly. Nothing stated herein shall tantamount to any expression of opinion on the merits of the case. Application stands disposed of. Bail application file be tagged with the main case file.
