ORDER

The counsel for the Accused No.1 and 2 filed advance application U/sec.346 of BNSS and U/sec.275 of BNSS and prays to permit the Accused No.1 and 2 to guilt the offences punishable U/sec.20(b)(ii)(A) of NDPS Act. Case advanced. Accused No.1 and 2 are produced from J.C through V.C. Plea recorded and read over to them. The Accused No.1 and 2 plead guilty. They are in J.C from 05.09.2024 to till today. Hence, Accused No.1 and 2 are convicted U/sec.276 of BNSS for the offence punishable U/sec.20(b)(ii)(A) NDPS. The Accused No.1 and 2 sentenced to one month each simple imprisonment and to pay fine of Rs.5,000/- each for the offence punishable U/sec.20(b)(ii)(A) NDPS. Both the sentences shall run concurrently. Perused. It is seen that, the Accused No.1 and 2 have been J.C from 05.09.2024 for a period of 1 month 9 days. Hence, the imprisonment period of one month sentenced to Accused No.1 and 2 is hereby set off as against the sentence. Further, in default of payment of fine, both the accused No.1 and 2 shall each undergo simple imprisonment for period of 7 days, each. The Accused No.1 and 2 are set at liberty pertaining to this case, if they are not required in any other case. Issue intimation accordingly. It total, the Accused No.1 and 2 shall pay a fine of Rs.10,000/-. The case is hereby closed.
