As per latest order of Hon'ble High Court vide no. 569/RG/DHC/2021 dated 19.08.2021 & subsequent order no. 24818–24877/PD&SJ Sectt./COVID/North/RC/2021 dated 21/08/2021 of Id. Principal District & Sessions Judge, North, Rohini Courts, vide which it is directed that the physical hearing in District Court of Delhi shall resume in a graded manner w.e.f. 07/09/2021 & the judicial officers shall hold the Court physically on alternate days basis on the allocated day as per roster, while the other continue to hold Court through videoconferencing on non-physical days w.e.f. 07/09/2021 till further orders. It is further directed that all the judicial officers shall permit hybrid hearing/video-conferencing hearing, where-ever possible, if a request to such effect is made by any of the parties and/or their counsel on the date of physical hearing of Court. It is further directed that directions issued vide office order no. 256/RG/DHC/2021 dated 08/04/2021 that no adverse orders shall be passed by the District Courts of Delhi in case of non-appearance of parties and/or their counsel stands withdrawn w.e.f. 07/09/2021. It is further directed that only ex-parte evidence can be recorded.

The case is fixed for arguments on charge. The same is taken-up through Webex meeting app since Id amicus curiae for accused persons has appeared through webex having ID No. **1761575605**. The official email ID of this Court is reader.asj04north@gmail.com.
