This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

In view of the circumstances and the submissions of Ld. Counsel for the applicant as well as marriage of younger sister of applicant/accused is scheduled for 13.11.2025 and his presence is required for performing the rituals. Therefore, on humanitarian ground **interim bail of applicant/accused Sunil is allowed for a period of three days (w.e.f. 12.11.2025 to 14.11.2025) on furnishing personal bond in the sum of Rs. 30,000/- with one surety in the like amount subject to the satisfaction of following conditions:-**

- (i) Applicant/accused is directed to surrender before the concerned Jail Superintendent after the expiry of interim bail.
- (ii) Applicant/accused is further directed not to threaten the prosecution witnesses or tamper with evidence or indulge in any such crime.

In case, it is prima facie brought to the notice of the court that the applicant/accused is violating the said conditions, the interim bail granted to him shall be liable to be canceled.

Applicant/accused Sunil is directed to surrender before the
