Reply to the above said application has been filed by IO. Same is taken on record. Copy of the same supplied to Ld. Counsel for applicant/accused.

Ld. Counsel for applicant/accused submits that applicant/accused is in JC since 25.08.2024 and he has been falsely implicated in the present case. It is further submitted that applicant/accused is innocent and he has not committed this offence as alleged against applicant/accused. It is further submitted that nothing has been recovered from the applicant/accused as alleged by the prosecution and the alleged recovery is false and planted one. It is further submitted that applicant/accused is no more required by the prosecution for any law full purpose no fruitful purpose would be served to keep the applicant/accused behind the bar. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, initially the present FIR bearing no. 610/2024 has been registered at PS Shahbad Dairy U/s. 309(4)/3(5) BNS & U/s. 25/27 Arms Act and later on, the offences punishable U/s. 309(6)/317(2)/311/61(2) BNS have been added in the present FIR case. The allegations against applicant/accused **Sunil** are that he alongwith his other co-accused persons committed robbery of cash amounting to Rs. 6,13,000/- on gun point. Further, it is also the case of the prosecution that cash amounting to Rs. 4,00,000/- out of the robbed money and a countrymade pistol which was allegedly used in the commission of the alleged offence has also been recovered from the possession of applicant/accused **Sunil**. Applicant/accused **Sunil** is also involved in many similar offences in past as the previous involvement record which shows that he is a habitual offender. Releasing applicant/accused **Sunil** at this stage may result in threat to the victim.

Keeping in view of the above discussion and also considering the severity and the gravity of offence as well as seriousness of allegations, the present bail application of applicant/accused **Sunil** is hereby dismissed.

Nothing stated herein shall tantamount to any expression of opinion the merits of the case. Copy of order be given dasti to the
